Third Sector organisations are run by volunteers (trustees), and use any money they receive for their beneficiaries.



Stirlingshire Voluntary Enterprise (SVE) is the development and partnership agency for the third sector in Stirling. Our members are locally based charities, social enterprises, voluntary and community organisations.

We are proud to be the third sector interface (TSI) for Stirling- and work closely with other TSI's across Scotland through the TSI Scotland Network.

- Share responsibility for the good financial management of the charity.
- Represent SVE to key agencies and stakeholders such as government, funding bodies, the community sector and the media.

You will carry out your role by:

- Attending meetings of the SVE Board and ad hoc development/ strategy days.
- Joining a sub committee of the SVE Board such as HR and Health and Safety, Finance and Risk or Governance.
- Report to the Annual General Meeting of SVE members.

Much of the Board's business will be conducted electronically and you will be expected to have regular access to email/online meeting software.
