	Donna Hegarty is a Business Development Officer from Neighbourhood Networks. She spoke about the work of Neighbourhood Networks, which provides servicers in the main part for people with learning disabilities. Members of Neighbourhood Networks get the flexibility and responsive support to meet their own personal care needs. Each individual is supported to establish a life in which they are safe and more independent. Members will have opportunities to experience a real sense of belonging and involvement They have various networks across Scotland from Glasgow to Falkirk. They are trying to establish if there is a need for the service in Stirling and are hoping to expand. They have a specific service around transitions for people between the ages of 16-25.	
	Neighbourhood Networks is assessed by the Care Inspectorate as a housing support organisation and aim to support people to maintain their tenancy.

	Elizabeth Ramsay from Central Carers gave an update on the IJB. This year there is an overspend of £4.6 million. In order to curb this, there needs to be cuts. Care packages are becoming more expensive. A possible review of incontinence services and production services might happen. Clackmannanshire has the highest rate of suicide in Scotland.	
	The Health and Social Care Strategic Planning Group has held a workshop on respite/ short breaks for carers.	
	MSG (Ministerial Steering Group) Report stated that they will be visiting Third Sector providers before the end of March 2020. There will be a shift in culture and the MSG want to see more integrated teams. Greater clarity on what funding for each TSi is needed.	
	Anthea Coulter drew attention to future developments in the commissioning process and difficulties experienced by smaller support organisations. The MSG identified greater need for clarity on all the funding that goes to the Third Sector and better engagement with these groups.	
	An initiative around community links workers is currently being worked up and will complement the wellbeing drop-in at the Speirs Centre on alternate Thursday mornings. CTSI and partners have applied for funding for some community health champions.
